homes and maintaining the look of our neighborhood. During the past few months, a new category of review was added to the neighborhood drive report, and to date, we are comfortable this new tier is accomplishing the desired results. In years past, the neighborhood drive report contained three levels. If an issue appeared on the report, it would advance, if left uncorrected, thru three levels. These three levels still exist and are: friendly reminder level, warning level and fine level. During the late summer of 2005, a 'watch only' level was added to the neighborhood drive report. This means that if a minor issue is identified, but it appears to be temporary, the issue is added to the report for reference, and no letters

are sent to the owner. Then, when the next neighborhood drive report is created, review determines if the issue was resolved, and if it was, it is removed from the report. If the issue still exists, the watch item advances to the friendly reminder letter level. Since the implementation of 'watch only', owner letters have decreased, as many issue resolved themselves without a letter. And this makes the ACC happy. Information regarding Arbors restrictions and policies is also available on the Improvement Association web site. Becoming familiar with and understanding the restrictions and policies being enforced within our neighborhood also prevents letters and supports voluntary compliance.

Siren Proposed

The recent dry weather and resulting fire danger has lead the AIA Board to research the installation of a community alert system in our neighborhood. The siren would be used to warn residents of impending danger, such as a fire. not down the middle of the street for your safety. You should always walk or run opposite the flow of traffic so you can see oncoming vehicles. Bicycles should always ride on the right with the flow of traffic.

The drought conditions present a very serious threat of fires within our community. We all need to be extremely careful and be sure we follow all of the warnings that are issued by the County. Signs are kept updated at the two main gates of our community with the current warnings. One careless individual tossing a cigarette or even lighting a grill could cause a disaster in the Arbors. If you notice any violation, please contact a member of the Board.

E-mail notices are sent each month reminding the residents of the

meeting and also used on an as needed basis to inform the residents of any important issues such as the burn ban and notification of incidents that affect the residents such as gates going to be closed for repairs. If you do not have an e-mail on file and would like to receive notification notices such as these, please send the information to ArborDirectory@austin.rr.com. This notification is used only for official Board business.

The Board Meeting is held the second Wednesday of every month at the FNB in Elgin at 7 p.m. Everyone is invited and encouraged to attend the meetings. The Arbors Improvement Association has added a “High Wind Warning” to the existing burn ban signs located at both entrances. The Texas Forest Service will issue these Red Flag Alerts when fire danger is increased by high winds and dry conditions. A fire will spread quickly and easily under such conditions and can even jump across freeways.

Chemical Edging Investigated

Recently, residents have expressed concern about the use of chemical edging along our streets. John Redmon, chairman of the Maintenance Committee, has researched the use of a “green” product for weed control along the roads. The Natural Gardener suggests a naturally based product as an alternative to Roundup, the current chemical that is used in the Arbors. The information obtained indicated that the recommended “green” product is potentially more dangerous than Roundup. In addition, the “green” product is more expensive to use and would require several applications.
